

Thank you for booking a fishing charter aboard *The Double Wrap*. Please read below for important information about your charter. If you have any questions or concerns, please do not hesitate to reach out to us via email, text, WhatsApp, or phone call.

## **About Your Fishing Charter:**

- The Double Wrap is located at the Perry Hotel and Marina slip A-14, 7001 Shrimp Rd. Key West, FL 33040.
- When you arrive at *The Perry*, the slip is located on the rear of the hotel, adjacent to the main pool and *Salty Oyster* Bar and Grill.
- Parking is free in the parking lot on the property. Please park in the marina village parking lot, not the hotel parking lot. To get there, continue past the hotel entrance and marina village will be the first entrance on your left.
- Please arrive <u>10-15 minutes</u> prior to your scheduled charter to ensure an on-time departure.
- We will provide bottled water on your trip. Please feel free to bring food, snacks, and drinks to be stored in the onboard cooler or fridge.
- We suggest that you bring sunscreen, hats, sunglasses, and any motion sickness remedies that you may need with you on your trip.
- We will gladly clean and filet the fish you wish to keep; you may choose to bring a cooler for you to store your catch in after the trip.
- All fishing tackle, gear, bait, lures, license, insurance, and safety equipment is provided.
- An 18-20% gratuity is greatly appreciated and a primary income of the crew.
- Whether it be your first-time fishing, or you are an avid angler, the Captain and First Mate look forward to welcoming you on the *Double Wrap*.

Participants: We can accommodate up to 6-anglers on a private charter.

**Deposit:** A deposit was due at the time of booking to secure the date of your charter. Payment of the final balance may be paid to the Captain on the day of the charter using cash, a credit card, or Zelle. If you use a credit card, please note that a 2% processing fee will be added to the total. Cancellations made 30-days prior to the reserved date will receive a full refund. Charters not cancelled within 30-days of the reserved date will forfeit their deposit. If

you must cancel your reservation within 30-days, we will try to make arrangements for another date with your deposit. 'No-show' situations will be responsible for payment of the <u>full price of the trip.</u> Payment in full is due at the time of the charter and all sales are final.

**Weather/ Alternate Cancellation Policy:** Captain Craig Hassell will cancel any trip for weather or winds exceeding 20 knots and will provide a full refund. If the captain needs to cancel a trip for any other reason a 100% refund will be made if another date cannot be arranged to your satisfaction.

Client Consent Form: Please see below for an example of the release that all members of your group will be asked to sign on the day of your charter. If you have any questions about the release, please do not hesitate to reach out to us. It is important for you to know that this document is required from all participants prior to embarking on the charter. If anyone in your trip refuses to sign the release on the day of the charter, they will not be permitted to attend.

**Media Release:** I grant permission to Drop Off Sportfishing, LLC to use my image (photographs and/or video) in Media publications, including social media, website, and marketing materials. I hereby waive any right to inspect or approve the finished photographs or electronic matter that may be used in conjunction with them now or in the future, whether that use is known to me or unknown, and I waive any right to royalties or other compensation arising from or related to the use of the image or video.

**Informed Consent and Release of Liability:** I, Captain Craig Hassell, certify that I have a U.S. Coast Guard 6-pack Captain's License, and I am legally qualified to take passengers on offshore fishing charters. I have over 15 years of fishing experience and will take every necessary safety precaution as your Captain. I vow not to take any unnecessary risks and will avoid any bad weather to the fullest possible extent. My goal is to make your trip both safe and memorable. It is important to note that with adventure tourism, boating, and fishing, there are inherent risks that cannot be controlled or eliminated. You must be aware of these risks before you take a trip with us. Please take the time to read this contract, and do not sign it until you fully understand it in its entirety. Please ask for clarification if needed.

I, the undersigned, fully understand that I am boarding a charter fishing vessel to fish in open water. I have read, understand, and am assuming the risks and hazards associated with offshore fishing by signing this waiver.

The below-mentioned risks include, but are not limited to:

• Sun, rain, lightning, sea spray, and any other weather condition; seasickness; dehydration; pitching and rolling of the vessel; slippery and wet decks; bodily injuries, both internal and external; boarding and disembarking the vessel; tackle and gear; death; drowning; insect or animal bites; and any other harm which may be encountered while participating in fishing and boating.

I understand that offshore fishing is not recommended for anyone with pre-existing medical conditions such as circulatory problems, high blood pressure, heart conditions, pregnancy, weak bones, etc. I understand that in the event of illness or injury, appropriate care must be summoned by radio, and treatment will be delayed until transportation to a proper medical facility is arranged. I agree to hold harmless the Captain and/or Crew and/or passengers for actions taken in attempting the performance of first aid.

I verify that I am not in possession of any illegal substances, and I release Drop Off Sport Fishing, LLC from any liability whatsoever for any unlawful actions taken by myself on the vessel. I understand that if it comes to the attention of the Captain or Crew that I have any illegal substances or participate in any illegal actions, the charter will end immediately, and no reimbursement for the remainder of the trip will be provided.

I understand that the consumption of alcohol may increase the risk of injury around water and boats, and I recognize that if I choose to consume alcohol while on board the vessel, it is at my own risk, and I assume all liability. Drop Off Sportfishing, LLC, its Captain, and Crew shall be held harmless from any and all claims for personal injury or death arising from or related to, directly or indirectly, the use or consumption of alcohol or drugs, even if the personal injury or death is caused in whole or in part by the negligence of Drop Off Sportfishing, LLC. For your safety and the safety of your fellow passengers, Captain, and crew, the Captain has a right to deny any person on the boat that is visibly intoxicated at the start of the trip.

I have read this waiver on the reverse of this signature page and understand that it is a legal document designed to inform me of the risks associated with offshore fishing and release the Captain, Crew, and Drop Off Sportfishing, LLC from any and all liability for personal injuries, death, illness, or damage to property, arising from my participation in this

fishing charter. I agree and acknowledge that I have read this release and fully understand the contents of this entire document, understand that it affects my legal rights, and agree to be bound by its terms. I understand that I am free to address any specific questions regarding this release prior to signing, and I agree that my failure to do so will be interpreted as a free and knowledgeable acceptance of the terms of this release. I execute it voluntarily and with full knowledge of its significance.

\*No signature is required prior to the charter; a printed copy of the release will be provided to your group to sign on the day of your charter.
